THE INFORMATION WE COLLECT ABOUT YOU

Some of the ways information is collected include:

- When you contact us by mail, telephone, e mail, or interact with us through electronic means - including websites, social media, discussion groups, conference calls, mobile applications;
- When you support us through donations or purchases goods or services;
- If you take up a voluntary, contracted, or employment position;
- Where we provide services to you;
- When you give information in person

The information you give us may include identifiers such as your name, postal address, e-mail address, phone number, church attended, credit card or financial information, other personal information, description, age and/or photographs. Other information will be required if you are a volunteer, employee, student or instructor.

All activities of Word Of Life Bible School may be recorded and photographed. Images of the people attending or participating in the activity or other event may be used in print material, promotional videos, live-streaming and for other promotional purposes and commercial activities. By attending any event, service or other activity you agree to Word Of Life Bible School using your image and personal information in these recordings. In addition, the following may be collected during a website visit:

- Technical information, including your Internet protocol (IP) address (used to connect your computer to the Internet), your login information (if appropriate), browser type and version, time zone setting, browser plug-in types and versions, and operating system and platform;
- Information about your visit.

If you are an employee, volunteer, a Word Of Life Bible School student, or a church congregant we may also hold certain categories of sensitive information such as personal financial details, gender, marital status, full employment and educational history, references, medical and criminal records, and student records.

Where practicable, the purpose for which we collect personal information will be made clear at the time of collection. If you do not provide us with certain information we may be unable to provide you with certain services or assistance requested.

We also gather information on children with the consent of Parents / carers. Relevant information will also be given to children in an appropriate way. At the age of 13 children will also be asked for their permission for storing their information.

WHAT IS OUR LEGAL BASIS FOR PROCESSING YOUR DATA?

The legal basis for processing personal data differs depending upon the purpose it was collected for. This includes consent, agreement, for legitimate interests, or for legal reasons.

YOUR RIGHTS

You have various rights under GDPR, which this policy upholds:

- The right to be informed about our collection and use of personal data;
- The right of access to the personal data we hold about you;
- The right to correct any personal data we hold about you that is inaccurate;
- You have a right to ask us to delete any personal data we hold about you. To do this please email us at admin@wordoflife.co.uk. An exception is where we are required to hold the data by law or because we must have the information for a particular reason e.g. for Gift aid, safeguarding or student records.
- The right to restrict (i.e. prevent) the processing of your personal data;
- The right to data portability (obtaining a copy of your personal data to re-use with another service or organisation);
- The right to object to us using your personal data for particular purposes; and
- Rights with respect to automated decision making and profiling.

Data that is held on consent will only be processed as long as we have your consent. To withdraw your consent, you can contact us by emailing us at admin@wordoflife.co.uk.

You may access our websites without providing any data at all. However, to use all features and functions available on our websites you may be required to submit or allow for the collection of certain data. You may restrict our use of Cookies.

If you have any cause for complaint about our use of your personal data, please contact us at admin@wordoflife.co.uk and we will do our best to solve the problem for you. If we are unable to help, you also have the right to lodge a complaint with the UK's supervisory authority, the Information Commissioner's Office. ACCESS TO YOUR INFORMATION

You can request access to the personal information that Word Of Life Bible School holds about you by contacting the Data Lead. Word Of Life Bible School will provide you with access to your personal information unless legally authorised to refuse your request. Word Of Life Bible School does not charge for providing reasonable access.

If you wish to change personal information that is out of date or inaccurate at any time, please contact admin@wordoflife.co.uk. After notice from you, Word Of Life Bible School will take reasonable steps to correct your information. If you wish to have your personal information deleted, please advise Word Of Life Bible School and that information will be deleted wherever practicable.

Word Of Life Bible School may refuse your request to access, amend or delete your personal information in certain circumstances. If Word Of Life Bible School does refuse your request, you will be provided with a reason for such decision and, in the case of amendment, it will be noted with your personal information that you have disputed its accuracy.

HOW WILL WE USE THIS INFORMATION?

Word Of Life Bible School will use the personal information we collect for the purpose disclosed at the time of collection, or as set out in this Privacy Policy. We will not use your personal information for any other purpose without first seeking your consent, unless authorised or required by law. Generally, we will only use and disclose your personal information as follows:

- to establish and maintain your involvement with Word Of Life Bible School;
- to provide the products or services you have requested from Word Of Life Bible School;
- to answer your enquiry;
- to register you for events, conferences or promotions;
- to assist us to make our sites, services and products more valuable;
- for direct promotion of products or services;
- to third parties where they provide the services you have requested; and
- to maintain accurate and up to date records of our employees, volunteers, and students.
- to run criminal record checks for Safeguarding or employment purposes;
- to meet any legal requirements or as per agreements for use of services from Word Of Life Bible School.
- to provide Pastoral care or ministry.

Where you have consented when providing us with your details, Word Of Life Bible School may also allow carefully selected third parties, including other ministries and organisations in our group, to contact you occasionally by email about products and services which may be of interest to you. If you change your mind about being contacted by these organisations in the future, please contact admin@wordoflife.co.uk.

Outside where stated above unless otherwise required to do so by law, we will not otherwise share, sell or distribute any of the information you provide to us without your consent.

Where we transfer any personal data outside the EEA, we will take all reasonable steps to ensure that your data is treated as safely and securely as it would be within the UK and under the GDPR.

SECURITY

- Only Word Of Life Bible School staff, volunteers (and the staff of our Business Partners) that need to see the data can access it.
- We may store your information on computers, in paper form, or both.
- All computers that store any personal data are password protected.
- Laptop computers and similar devices that contain confidential information are encrypted where possible.
- Any paper files that hold personal information (other than names and contact details) are kept on secure premises in locked cupboards and filing cabinets.

- Any personal information that is transferred to, and stored at, a destination outside the European Union (“EU”), will also be processed by staff operating outside the EU who work for us or for one of our providers. This includes staff engaged in, among other things, the fulfilment of your requests for services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy and in compliance with all relevant UK data protection legislation.
- Information you provide may be stored on our secure servers or by one of our business partners. Where we have given you (or where you have chosen) a password that enables you to access certain parts of our site or app, or a business partners site or app, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.
- Unfortunately, the transmission of information via the Internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.
- The services used by Word Of Life Bible School to receive and process payments (PayPal, Square, Stripe, and GoCardless) all use end to end encryption.

HOW LONG DO WE HOLD YOUR DATA?

Generally speaking for the school and the church your information will be held whilst we provide you a service and for seven years after your last contact with us. An exception to this would be if we had to hold it for longer if required for legal or Governmental reasons.

For Students and Alumni we will hold your data for as long as we provide you a service, may need to give a reference or to confirm your qualifications.

Data that is held by us on consent is only kept for as long as we have your consent to process that data.

COOKIES

Cookies are small amounts of information that Word Of Life Bible School websites store on your computer. Unless you have indicated your objection when disclosing your details to Word Of Life Bible School its system will issue cookies to your computer when you log on to the site.
